



#### **About the Auction**

For some time now I have been asked to write an article for TAP about the ACC auction. The problem with this worthy idea is that by the time I finish assembling and attributing the auction lots, my philatelic energy is pretty much used-up and the idea remains in the pile of good intentions.

As a compromise to a full length article about the auction, I've agreed to do a short column for each issue of TAP to address various auction-related topics. For this first column, let's get down to the basics regarding one of the primary ways that you, as a member of the ACC, can actively participate in the auction -- By Bidding!

For seasoned bidders in the ACC auction, this subject likely seems an unnecessary one to address; however, based on the limited number of ACC members who bid in the auction (rarely more than 15 to 20), I'm guessing we have some bidding Chechacos out there. Don't let just a few have all the fun as these shrewd, sagacious members always snap-up over 50% of the lots offered!

To get started, one needs to read the introductory material at the beginning of the auction. Doing so will help you to understand the abbreviations used in the lot descriptions and to realize that many of the items have a very low reserve or required minimum bid. Mind you, there are some other great items (like the elusive cancel from Dome, a great 1898 cover from Orca, and three

classics from Iditarod) in this auction with considerably higher starting bids.

The reserve ("R = \$x.xx" in the lot description) is the minimum amount that will be accepted as a bid on the lot. In this auction, a lot description without an "R = \$x.xx" in it has a minimum bid of only 50-cents! In contrast to this minimum amount (which is an acceptable and sometimes winning bid), conventional wisdom suggests that one should bid whatever the lot is worth to them. If you are the high bidder, then you will win the lot at your bid amount, or quite often at a lower (sometimes much lower) price depending on bids made by other auction participants.

You can write your bids by lot number on the bid sheet provided with the auction and mail it to me, send them to me in an E-mail, or call me on the phone. Hand delivery of bids is also acceptable, but that has not happened since I last lived in Juneau!

Bids need to be made on or before the closing date of the auction (bids that are mailed need to be postmarked on or before this date). Successful bidders will receive their winnings along with an invoice that includes a small shipping and handling charge a couple of weeks after the closing date. Prompt payment is always appreciated.

This auction contains a wide range of statehood and territorial items that I have tried to accurately describe. If you are interesting in bidding on an item, but are confused by the description, then drop me a note (E-mail or snail mail) to clarify the description or to request an image. The images provided within the auction write-up can guide you in understanding the particular lot shown as well as in visualizing others lots with similar descriptions.

The ACC auction provides club members with an excellent means to obtain quality items of Alaska Postal History at very reasonable prices. Trust me; I know this to be true. As such, bidding, which is limited to ACC members, can be both fun and rewarding. So, why not give it a try and bid!

This auction is already an ACC record-setter in that it contains the most lots in the 15 + years that I have been the Auctioneer. It would be nice to set another record with this auction and have it also be the auction with the most club members bidding and winning!

#### Canadian Postal Corps No. I and CAPO 51

On July 12, 1943, the Canadian 13th Infantry Brigade sailed from Vancouver Island aboard four United States Army Transports bound for Adak, Alaska. The Canadian Force, code named GREENLIGHT, consisted of four infantry battalions (Canadian Fusiliers, Winnipeg Grenadiers, Rocky Mountain Rangers and Le Regiment de Hull), the 24th Field Regiment, Royal Canadian Artillery, engineer and machine gun companies, and a medical detachment. In all, the Canadians numbered 4,800 officers and men.

The Canadians arrived on Adak on July 19 and continued training in preparation for the invasion of Kiska. For nearly a month they worked together with their American comrades in arms to minimize confusing details or organization and terminology. On August 15 the 13th Brigade landed on Kiska as part of the Northern Force along with the US 184th Infantry Regiment, and a Regiment of the First Special Service Force, a joint American-Canadian combat regiment.

Immediately after the island was determined to have been devoid of Japanese, the First Special Service Force was returned to the United States. They arrived before the end of August. The 13th Infantry Brigade, however, remained on Kiska four months and did not reach British Columbia until mid-January 1944. While on Kiska the Brigade was served postally by Canadian military post offices. Two different types of postmarks are known on mail originating from this unit during its Kiska occupation. Examples are listed as scarce to rare and almost all of those seen by this writer have been applied exclusively to US stamps or postmarked 'Free'.


#### United States APO's at Adak and Kiska

US Military personnel were served postally through APO 980 on Adak. APO 980 was officially established on Adak on August 3, 1942, however, the first troops did not arrive until August 30. The intent was to prepare for the invasion of Kiska. The importance of Adak peaked in mid-1943 with the invasions of Attu and Kiska. The earliest reported APO postmark to date from APO 980 is September 17, 1942.

The other APO serving US troops in the area was APO 730 which was established at Adak effective August 8, 1943 and transferred to Kiska effective August 17, 1943. The Kiska operation was dubbed operation COT-TAGE by the American forces. The massive invasion occurred on August 15, 1943, and no Japanese were ever seen on the island, having vacated the area after receiving orders from the high command on June 8 and evacuating on July 28. The search for Japanese continued until August 22 when most of the American forces were withdrawn and reassigned elsewhere. The earliest reported APO postmark bearing an APO 730 cancellation is dated August 4, 1943 with a Medical Detachment return address (probably in transit prior to arrival at Adak). The next reported postmark using the APO 730 cancel in dated September 5, 1943(after return to Kiska).

#### 100th Anniversary of the Ester Post Office

#### A Club Member's Introduction

On September 15, 2006 the people of Ester, Alaska were joined by members of the U.S. Postal Service in celebrating the Centennial of postal service at Ester. Until 1965 the post office was known as Berry, Alaska. By coincidence, our club had for auction a postal card written by Bertha Moody, Postmaster in 1943, which clarified the relation between the names of the post office, Berry, and the community, Ester. Through the kindness of ACC Auction Manager Terry Shaw, we were able to use copies of that postal card as the graphics for the official celebration program.

Postmaster Bill Ackiss sought and received extensive community involvement in expressing the theme of the celebration, "Providing a Century of Service to the Arts and Mines of Ester", the post office was decorated with the work of many local artists, and antique mining equipment from local miner, Jerry Hassel. A commemorative cancel incorporating the theme was also created.

Postal officials attending the celebration were Ms. Dianne Horbochuck, USPS Alaska District Manager, Postmaster Bill Ackiss, Ruth Jasper (Long), who was the longest serving postmaster in the history of the post office, 30 years. And a very special guest came out from Fairbanks to join the celebration, James Moody, the son, and grandson of three former Berry postmasters. Indeed, his presence along with the postal card about Ester, provided a path back through more than half of Ester's history, for the card was written by his grandmother, in 1943.

One final note, I was the successful bidder on the Moody card, and it will now remain in Ester as a historical icon. We all are very thankful for the graciousness of the Alaska Collectors Club in allowing us the use of the card while it was still up for bid.

#### THE POSTAL NEWS

100 Years of Going Postal

The centennial celebration at the Ester Post Office on September 15 brought the population of Ester out in droves, providing good news fodder for KTVF TV—that's Channel 11 for those not on the cable system—and

the Fairbanks *Daily News-Miner* (not to mention these belated stories in *The Republic*). Folks got dressed up and the yellowjacket population turned out to forage for goodies. Postmaster Bill Ackiss looked positively polished and even more cheerful than usual. A table laid with coffee and carrot cake was set outdoors on the Village Road side of the building, a podium borrowed from the Ester Volunteer Fire Department was set in front of the entrance, and there was a pavilion with commemorative envelopes, stamped and cancelled with the centennial postmark (pictured above).

The cake bore a screened photo of the post office done in purplish icing. Postal bigwigs came up from Anchor-

age for the occasion: Dianne Horbochuck, Alaska District manager; Kathy Loera, postal retail specialist; and Kathy Phillips, marketing manager.

Birthdays call for speeches: Postmaster Bill started things off, jollying the throngs and introducing various postal people and what passes for dignitaries in Ester. Community association president Frank Therrell pointed out that Ester was news, waving a copy of the News-Miner with a photo of a nearby picturesque pond featured on its front

page, and spoke about the community's tight-knit spirit and can-do attitude, using the local library as an example. He ended his speech with an exhortation to support the post office, to get out and meet your neighbors there: "Buy more stamps. Forget about those e-mails." Bill's boss, Dianne Horbochuk, teased him about his obviously not having enough work to do, much to the amusement of the assembled, and talked about the history of the Berry/Ester post office, drawing on Matt Reckard's "fine research" into the matter. I told an only slightly embroidered tale or two about how the post office was saved from oblivion by the stubborn and determined efforts of many a generation of Esterites.

Speeches were interspersed with jokes and a drawing: two framed copies of the Byron Birdsall stamp and print commemorating the Alaska Highway were given to two

attendees. Jamie Smith and Jean Lester, artists both, were the lucky winners. Lisa Sporleder sang; Monique Musick acted as the post office's official photographer; and Kate Billington and Sandy Willis were on duty. Politicians showed up to glad-hand the crowd: Jason Crawford, David Guttenberg, Mike Musick, Joe Thomas. Local artists displayed their work all over the grounds and within the building, among them: Craig N. Buchanan, Gary Grata, Ray Hadley, Ellen Harney.

The post office sold special centennial envelopes cancelled with a commemorative postmark (see p. 19) for a dollar.

Frank Therrell described in his speech how, many years

ago, he was lying on the spot where the post office is now, enjoying the sunshine and listening to Led Zeppelin for the first time. "I haven't been the same since!" he declared, to the appreciative (and knowing) laughter of the audience.

Deirdre Helfferich, Jean Lester, Amy E.C. Luick, Peter

McRoy, Hans Melders, Jeff Rogers, and Sherri Schleiter. George and Bobbi Lounsbury provided a copy of a letter written in 1937 about mining activity in Ester, mailed from the Berry Post Office. Jerry Hassel provided some old mining equipment, from a hydraulic cannon to shovel, pick, and goldpan, for display on the lawn.

About a hundred or more people showed up to the event, which is saying something, given that it was at one o'clock on a workday. The celebration lasted only a couple of hours, but, as Ray Hadley's suggested theme expresses best, the post office served both arts and mines of Ester that Friday just as it has for a hundred years—and as the village of Ester certainly seems to expect that it will for the next hundred.

Ackiss introduced several former postal workers who attended the centennial celebration, among them Kay Sisson and Ruth Jasper. There have been four postmasters during the time that our post office has been the Ester Post Office; Ruth Jasper was the longest-serving postmaster throughout the station's history. When she retired, she

had run the post office for thirty years. Bertha Moody was the only other postmaster who came even halfway close, having served for fifteen years. Bertha was Edson Moody's mother; Edson was Alaska's husband. See chart below for more detailed listing of Ester Postmasters.

#### Saving Ester

speech by Deirdre Helfferich, September 15, 2006, Ester Post Office Centennial Celebration

Once upon a time, the Ester Community Association, the Ester Community Park, the Ester Volunteer Fire Department, the John Trigg Ester Library, and the local newspaper inadvertently saved our beloved People's Republic of Ester from extinction. Or at least, that's how the story goes—like all perhaps apocryphal tales, parts of it are factual, and parts of it may be exaggerated to better reflect the truth.

To understand this story you need to realize the significance that the Ester post office has here in the village. The Ester post office is more than simply a place to send a letter or buy a stamp. If the Golden Eagle is Ester's living room, the post office is the parlor. It's Ester's news central, where people meet and find out what's going on. We've got the bulletin board, the book exchange, our neighbors and

friends as postal employees. Our post office has inspired postmasters elsewhere in the state: a recent example comes from the July 26 Fairbanks Daily News-Miner, in an article about the new Denali Park Post Office postmasters, who decided to follow our post office's model, with complete book exchange and community bulletin board.

(It helped that they used to live in the Ester area.)

In Ester, "going postal" has a somewhat different connotation than it does elsewhere. People like going to

the post office. There's art on the walls (and not just today, although there's a lot more art than we usually have), candy on the counter, odd trivia questions from the postmaster, and Klingons in the foyer from time to time. And stamps and mail and all the usual stuff. It's a

great place to meet your neighbors, find good books and magazines and berry buckets, and see who's selling what or performing in which concert or when the next art show or cookie exchange is. The post office is the heartbeat of Ester.

My first editorial in The Ester Republic, written in January 1999, was about "our one legally recognized bas-tion of Esterdom, that shrine of local news and communication: the Ester Post Office." The village of Ester is a legally recognized entity only within the interior of this log building you see here. Otherwise we are known variously as "the Ester Census Designated Place", or "the Ester Fire Service District", or "the Ester community," or "home of the Ester Extremist Wing", or, as many of us prefer, "The People's Independent Republic of Ester." This wasn't always the case: before the borough decided to make all street names in the borough unique, streets in Ester were in Ester, just as streets in Fairbanks are in Fairbanks. This wasn't satisfactory to the borough, however. Around 1996, after asking us nicely what we wanted our street names to be and putting those names on the map, we discovered that the borough had designated all the streets as being in the Fairbanks North Star Borough, or "Fairbanks," for short.

Somehow all of our houses and streets had magically moved to Fairbanks without budging an inch, and Ester had disappeared—except for the interior of the post office building, which is federal territory. The United States Postal Service wasn't apparently interested in accepting the sovereignty of borough-level bureaucracy.

So Ester was saved, as they say in the Malemute Saloon's show but then in 2000 came a new threat: rumor had it that the post office itself might be downgraded to a branch office of the Fairbanks post office, or made into a contract station. This happened around the time Ruth Jasper was set to retire from her position as postmaster. We'd lose our postmaster! We'd lose our collectible and art-inspiring Ester cancellation stamp! New

residents might think that they lived in a Fairbanks suburb! And worst of all, Ester would legally no longer exist!

This wasn't the first time that the Ester/Berry PO had been faced with obliteration. In 1901, as a supposed economy measure, the post office in Ester City, then in J.C. Kinney's store, was closed for rerouting to Chena. Ester City had 50 patrons and Chena had 5, so this made perfect sense. James Wickersham, the then-territorial delegate, had to intervene to get the Berry post office reopened. Then in 1915, the postal powers tried to close it again, but a massive lobbying effort by the locals saved it just six days before the scheduled closure. The uproar was so great that it took another eighty-five years before the postal service decided to contemplate tangling with Esterites again—or maybe they just forgot what a mess they were getting themselves into.

The Ester Post Office sold specially postmarked envelopes on September 15, 2006, in celebration of a century of service to the Ester and Berry communities. The envelope features a screened photo of the modern post office and the century station postmark made for the occasion. The postmark was designed by an Anchorage firm working on contract for the postal service. Ray Hadley came up with the "arts & mines" theme.

We did have another close squeak in 1971—the Wikstroms had the post office in their house then, and Mrs. Nora Wikstrom was the postmaster up until the end of October 1970. They sold their house to Lois Sala and moved out of town. However, this meant that Ester would only have thirty-five families getting their mail at the post office, which was one too few to keep the post office going here. (Lois got her mail in College.) Mrs. Elnna Wilderson had taken over as Officer in Charge and then postmaster, and explained the situation to Lois. So Lois started getting her mail in Ester, and our post office continued service unperturbed until 2000, and Ruth Jasper's impending retirement.


Whatever the reason for the long hiatus between attempts to axe the post office, Ester reacted in predictable fashion to the new threat, and the regional office of the

USPS was sent a lot of those little how-are-we-doing cards praising the Ester post office. Jeff Rogers claimed at the time that he sent hundreds! Now he's fessed up and recently said to me that he only sent four or five—but he wasn't the only one sending them.

In the end, however, it wasn't the cards that made the difference. Apparently, for a town to qualify for a general post office complete with post-master and official legal townhood in the postal service's eyes, a community needs to have certain minimum town-like services. This includes a local government or community association (ours was established in 1941), a fire department

(ours was official in 1974, but we'd had a bucket brigade long before that), a newspaper (est. 1999), and a public institution like a museum or school or library (est. 1999). So it turned out that we accidentally had all the necessary community ingredients, just in time, to save our post office and hence our official existence.

However, the People's Republic of Ester has existed for a good 100-odd years now without the government of the United States or the State of Alaska or even the Fairbanks North Star Borough's official recognition. Even though Joe Ryan (former borough assemblyman) did actually admit in print that we are a republic, nobody's sent an ambassador yet. But who cares? We've got our park, our newspaper, our library, our community association, our fire department, and, of course, our post office. We're independent, and we know it.





# Gold Nugget

The Naming of Nome: In February 1899, a group of 42 men who had staked property and mining claims on the Snake River near Nome City, officially agreed to change the name of the new mining camp to Anvil City, because of the confusion with the Nome River, which was located four miles to the southeast, and with Cape Nome, the point of land located twelve miles from the city.

The name change only made the situation even more confusing. The town was locally known as Anvil City for much of 1899, but the United States Post Office Department insisted on calling the community "Nome," apparently because it was thought that a town called Anvil City would be easily confused with the village of Anvik on the lower Yukon. A competing town site had been established at the mouth of the Nome River and it was also called Nome City. The Anvil City

merchants feared that the Post Office might decide to move the "Nome" Post Office from Anvil City on the Snake River to Nome City on the Nome River. After a vote was held, the merchants reluctantly agreed to change the name of Anvil City back to Nome.

Against its wishes, the city was stuck with the unusual name of Nome. Unlike other towns, which are named for explorers, heroes or politicians, Nome was named as a result of a 50 year-old spelling error. In the 1850's, an officer on a British ship off the coast of Alaska noted on a manuscript map that a nearby prominent point was not identified. He wrote "? Name" next to the point. When the map was recopied, another draftsman thought that the "?" was a "C" and that the "a" in "Name" was an "o," and thus a map-maker in the British Admiralty christened it "Cape Nome."

#### **News Item**

The U.S. Postal Service has announced that the 2007 International Polar Year souvenir sheet will be issued on February 22, 2007 in Anchorage. The sheet consists of two 84 cent stamps picturing the northern and southern lights.

The International Polar Year 2007-2008 will be high-lighted on a souvenir sheet Feb. 22, when scientists around the world will conduct research and field observations to increase understanding of the roles that both polar regions play in changing ecosystems, coastal erosion and other phenomena.

The sheet features two international rate stamps. One is a marvelous photograph of the aurora borealis. The second is an equally eye-catching photograph of the aurora australis. The souvenir sheet will only be available online at <a href="https://www.usps.com/shop">www.usps.com/shop</a> or by calling 1-800-STAMP-24. Advance orders will be accepted beginning Feb. 1st.

Two stamps in sheet format with similar designs will be issued later in 2007 at the new first class rate (probably 42 cents). The first day city has not been announced, but *Linn's Stamp News* thinks it will be another Alaskan city.

#### **Member Profile: Art Lyons**





My name is Art Lyons, and I live in East Greenbush, NY. I am retired and have been a stamp collector since childhood.

# Gold Nugget

The White Pass and Yukon Railroad still stands as one of the most astonishing engineering triumphs of the gold rush. Skagway's boosters, determined to create an easier route over the pass, lobbied hard for investors, dreamers and engineers to help make their plans a reality. That a railroad was considered at all is an amazing thought. The mountain's sheer cliff walls and steep grades must have made such an undertaking seem impossible to most.

To overcome such obstacles, engineers planned a narrow-gauge line, with rails 3' apart, instead of the recently regulated 4'-8 1/2". This shrank the roadbed from 15' to 10'. Workers used picks, shovels and blasting powder to clear a path for the train. Occasionally, the rumors of gold took their toll, and workers would disappear, along with the company's tools.

Construction began on the railroad at the end of May, 1898, nearly the same day as the Yukon River ice had broken enough to allow the thousands of stampeders camped along the shores of Lake Lindeman and Lake Bennett to start downriver to the gold fields.

By February 18, 1899, the railroad reached the White Pass summit. By July 6 of the same year, it stretched all the way to Lake Bennett. In the summer of the next year, the railroad reached as far north as Carcross, meeting the trainline that was being built down from White Horse. The cost for this enormous venture was over \$10 million.

The White Pass and Yukon Railroad is still running today, although ferrying tourists instead of gold seekers. The train runs on its original narrow-gauge track, rising from sea level at Skagway to 2,885' at the White Pass summit in only 21 miles.
