



This Pre-Klondike post office operated from 1890 until April, 1895 and was located inside Canada at Fortymile. The office was started by the famous trader, L. N. "Jack" McQuesten. Dr. Binner's excellent article, "Early Postal Service in the Yukon Valley and the Opening of the First Post Office - Mitchell, Alaska" is found in the Special CAPEX '96 Issue (Number 85) of the Postal History Society of Canada (PHSC) Journal dated March 31, 1996. I decided to join the PHSC and was able to purchase a copy of this issue. Those of you who are interested in the intriguing postal history of early Alaska and the Canadian North might check out the PHSC website and/or contact Stephane Cloutier, PHSC Secretary-Treasurer at cloutier1967@sympatico.ca. The PHSC is APS Affiliate # 67.

Robert Binner is in charge of the Munich Philatelic Library, one of the top 3 in Europe. Their website is only in German but has an online catalogue that can be searched by author or title. The address is www.muenchner-stadt-bibliothek.de/philatelistische-bibliothek.

Finally, I would like you to contact me if you have any information about our former ACC Secretary-Treasurer Carl Cammarata of Scotts, Michigan. Carl was also an Alaskan postal history dealer.

ACC By-Laws

Approved January, 1959 - Revised April, 1994

Article I: Name

The name of this organization shall be the Alaska Collectors Club.

Article II: Purpose

The purpose of this organization is to promote interest in Alaskan philately and to encourage research and study on all subjects pertaining to Alaskan Postal History.

Article III: Membership

Section 1. Any individual with an interest in Alaskan philately is eligible for membership.

Section 2. Applications for membership shall be made to the Secretary/Treasurer and shall be accompanied by the payment of annual dues.

Section 3. Yearly dues shall be assessed at a rate to be determined by the Board of Directors. The Board of Directors may establish, alter, or end any special membership types as seen fit. The dues structure shall be published in the organization's newsletter. Dues shall be payable on a calendar year basis. Members may be dropped from membership if renewal dues are not paid within 60 days after they become due.

Section 4. Any member guilty of improper conduct, after a fair hearing, may be suspended or expelled from membership by a two-thirds vote of the Board of Directors.

Article IV: Officers

Section 1. Officers shall be a President, Vice-President, Secretary/Treasurer, and three Directors-at-Large.

Section 2. No member shall hold more than one elective office at a time.

Section 3. A vacancy in the office of President shall be filled by the Vice-President for the remainder of the unexpired term. A vacancy in any other office shall be filed by appointment by the President, with the concurrence of the Board of Directors.

Section 4. The duties of the officers are:

President: The President shall have general charge of the affairs of the club and shall appoint all standing and special committees.

Vice-President: The Vice-President shall perform the duties of the President as circumstances may require and shall succeed the President if necessary.

Secretary/Treasurer: The Secretary/Treasurer shall keep a record of all proceedings of the organization, shall receive and process all applications for membership in the organization, shall maintain an up-to-date membership list, collect membership dues, make payments of expenses, and submit an annual report of activities to the organization.

Director-at-Large: The Directors-at-Large shall serve as voting members of the Board of Directors.

Article V: Board of Directors

Section 1. The President, the Vice-President, the Secretary/Treasurer, the three Directors-at-Large, and the Immediate Past President shall constitute a Board of Directors. The Board of Directors is established to assist in furthering the aims of the organization. The President of the organization shall preside as Chairman of the Board of Directors.

Section 2. Meetings of the Board of Directors shall be held as scheduled by the President. Special meetings of the Board of Directors may be held when requested by ten or more members or three or more members of the Board of Directors.

Section 3. The presence in person, or by other technological means, of a majority of its members shall constitute a quorum at any meeting of the Board of Directors.

Section 4. The Board of Directors shall make all decisions regarding the business and affairs of the organization and set policy as may be required, except on those issues presented to the membership as a whole for vote. They shall keep the membership informed of their actions through publication in the organization's official publication.

Article VI: Nominations and Elections

Section 1. Officers shall be elected for two year terms with the exception of the Secretary/Treasurer who shall be elected for a four year term. Elections shall be held in the odd-numbered years by mail ballot of the membership. A simple majority of the ballots cast shall be required for election.

Section 2. A nominating committee shall be appointed by the President during the first quarter of each odd-numbered year. At the same time a call for nominations shall be made in the official publication of the organization. The nominating committee shall present a slate of candidates to the President no later than June 1st.

Section 3. The election ballot shall be distributed to the membership in the July/August issue of the official publication. The ballots shall be returned to a designated election official within the club. The results shall be published in the November/December issue of the official publication.

Section 4. The newly elected officers shall assume office on January 1st.

Article VII: Meetings and Voting

Section 1. Because of the widespread physical locations of the members it is not practical to schedule regular meetings of the entire membership. Special meetings may be held in conjunction with major events in the philatelic world.

Section 2. Mail votes may be held on matters of major importance. Ballots shall be mailed to all dues-paid members. A simple majority of those voting shall indicate approval of the matter submitted to the membership and shall represent the decision of the entire membership.

Article VIII: Committees

Section 1. Standing committees may be established by the President as approved by the Board of Directors. Chairpersons shall be appointed by the President with the approval of the Board of Directors.

Section 2. Ad Hoc committees to further the affairs of the organization may be appointed by the President as may be desirable.

Article IX: Publications

Section 1. The organization shall issue a regular official publication called The Alaskan Philatelist. The frequency of publication shall be at least quarterly.

Section 2. The editor of The Alaskan Philatelist shall be appointed by the President with the approval of the board. The editor shall appoint staff as may be necessary. The editor shall be responsible for the preparation and content of the publication.

Article X: Parliamentary Authority

The conduct of this organization shall be governed by the latest edition of Robert's Rules of Order. In case of any conflict with the by-laws, the by-laws shall take precedence.

Article XI: Amendments

Section 1. The by-laws of the organization may be amended by a two-thirds vote of the Board of Directors. Any amendment adopted by the Board of Directors may be repealed or changed by the membership by a majority vote.

Section 2. The by-laws of the organization may be amended by a majority vote of the membership in a regular or special election.

Section 3. The Board of Directors may refer any proposed amendment to the by-laws to the membership for adoption in a regular or special election.

Article XII. Dissolution

Section 1. If circumstances warrant, the Board of Directors may submit a resolution to dissolve the organization to a vote of the membership. Approval shall be by a two-thirds majority of those voting.

Section 2. In the event the organization is dissolved, all assets will be distributed equally amongst remaining members, or, upon majority agreement, may be donated or distributed in whole or in part to any philatelic study organization the members desire.






An Opher Registration receipt (shown at 75%)



Items of Interest from Kodiak



Editors note: Mr. Hanko's letter arrived with one of the earliest of the new spray on cancels from Anchorage.




What a difference a couple of months make! The Chignik Postmaster Mr. Arthur Skonberg (now retired) decided to replace the worn out rubber stamp. I don't know how long he used the new one before I notified him of the misspelling.



The above 4 bar postmark is a new one for Kodiak. I have tried to find out the exact date but the clerk who has it cannot recall. Our Postmaster is on leave, Kodiak will have a new Postmaster shortly.



Here is another new Kodiak postmark! I will contact the Post Office and try to find out when they received it.



Although I received quite a few registered letters and fewer express letters from overseas during the last forty five years; this is the one and only cover that received this oversized double circle date stamp. In the old days when I worked at the Kodiak Post Office; 1965-1970, incoming registered, express and certified letters received a back stamp.

A member of the Anchorage club gave me this envelope. He said he gave his mailing address to a company over the phone and the address label was the result. In the past I have seen addresses like this get delivered when the city was wrong or the state was wrong, but the zip code was right. This is one of the few I have seen where the city name and the zip code were wrong, but it still made it.

There were no auxiliary markings on the envelope, just a barcoded zip code. The bar coded zip code also included the correct zip code number so the problem must have been caught early in the sorting process.

I guess it is an example of the post office delivering the mail, despite the best efforts of some senders. Note: The above zip code is is actually for Isabella, Minnesota.

Mail Service

The sudden and dramatic population growth overwhelmed Alaska's fledgling postal service. People waited months for their mail, especially during winter. When the steamship or dog sled finally arrived, miners could anticipate standing in line for hours, sometimes even days, before getting their mail. Those who were unable to leave their claims hired others to stand in line for them. Stampeders' devotion to their mail was so strong that when the postmaster of Glenora burned several sacks of mail instead of delivering it, he had to be spirited out of town ahead of a mob.

Only a few mail routes were in place prior to the rush. The postal services were no match for the quickly-growing, highly mobile population. Because of inadequate arrangements between U.S. and Canadian postal officials, bags of mail addressed to Klondikers piled up in Seattle, Juneau, Skagway and Dyea. The worst service was that received by the Americans in Dawson during the first years of the rush. During that winter, letters mailed in the U.S. addressed to Dawson were placed in the Circle City mail sacks. That mail then traveled through Dawson, as the carrier traveled on to Circle City, where the letters were sorted and then finally brought back to Dawson for distribution.

On March 3, 1898, the U.S. Post Office Department appointed John Philip Clum as the Postal Inspector for the Alaskan Territory. Clum arrived in Skagway on March 26th. He immediately set to work improving the area's mail service. During his months in Alaska, Clum traveled over 8,000 miles and established more than a dozen post offices in the territory. He carried everything he needed to create a post office with him–postage stamps, mailbags, postal locks, keys and postmarking devices.

Alaska's State Constitution Flag

In April of 2000, while attending an NEA meeting in Atlanta, Georgia, I made a side trip to visit my friends Bill and Louise Slee in Lady Lake, Florida. I have known them since my university days at the University of Alaska in Fairbanks in the early 1960's. While visiting them, their son, Sam, came to the house. Mrs. Slee said, "Sam, you should give that flag to David to take back to Alaska." I asked, "What flag?"

THIS IS THE STORY SHE TOLD ME

In 1960, Bill and Louise Slee and their children moved to College, Alaska to establish a mission church for the Board of American Missions of the United Lutheran Church of American. Louise Slee took a job in 1961 working as the senior typist for the university engineer, Ben Atkinson.

One day, Mr. Atkinson come out of his office with an Alaskan flag that he said he was getting rid of because it was frayed and damaged on the right side. He said it was the flag that was flying over Constitution Hall on February 6, 1956, the day the Alaska Constitutional Convention ended. Louise asked if she could have the flag, and Mr. Atkinson gave it to her.

The mission church did not pan out, and the Slees returned to Pennsylvania a few years later, taking the flag with them. Bill Slee became pastor of a Lutheran church in Carlisle, and then later in Williamsport, Pennsylvania. The Slees visited many churches in those areas presenting slide shows and talking about their Alaskan adventures and always took the flag with them.

When their youngest son, Sam, left home, he took the flag with him to New Kinston, Rhode Island. He said that at one time he used it as a curtain over one of his windows. Later, both Bill and Louise and Sam moved to Florida.

As I was getting ready to leave, Sam arrived at the house again and handed me a package containing the flag.

BACK TO THE FUTURE

The flag has been in a box in my house for the past six years. It was always my feeling that the flag belonged back at the University. With the 50th anniversary of the Alaska State Constitution Convention being held this year, it was a perfect time to take action. In December, I contacted the University and asked if they would be interested in having the flag, and of course they were very happy to receive it. When I called and talked to


the Slees about my plans, they were very excited. Louise said "I knew if we gave it to you, you would do the right thing."

A huge celebration was being planned at the University of Alaska for the weekend of February 3-5, 2006, and I was invited to attend, and present the flag to them. On Friday, February 3rd, I donated the flag to the University of Alaska during the 50th Anniversary celebration of the state constitution. It is my hope that the University will build a frame and mount the flag on a wall in Constitution Hall.


The weekend celebration was great. On Friday when I presented the flag, three of the convention delegates were in attendance, Vic Fischer, Jack Coghill and George Sundborg. Also present were the convention Secretary, Thomas Stewart; the convention Chief Clark, Katie Hurley; and two of the convention consultants, George Rogers and Dr. Ernest Bartley. What great stories they all had. After I presented the flag to Brian Rodgers of the University, we took time to take many pictures of the flag with the delegates and honored guests. It was a wonderful afternoon, and one that I will never forget.

On Saturday afternoon I attended a wonderful symposium, "THE ALASKA CONSTITUTION: THEN AND NOW." It was divided into two sessions. The first dealt with the writing of the constitution, and the second dealt with how well it has served Alaska the past 50 years. Saturday evening I attended the "50th Anniversary Celebration Dinner", and then viewed the debut of the documentary "THE 49TH STAR—THE ROAD TO STATEHOOD."

Being the stamp collector that I am, and my interest in Alaska history, I couldn't pass up making a few covers to commemorate the event. I canceled some covers at the University of Alaska post office, and also some at the College Branch of the Fairbanks post office. When I returned to Anchorage, Bob Spaugy helped me to complete the covers. Two of the covers are shown with this article. One of the covers shows me presenting the flag to Brian Rodgers, and the other shows the three convention delegates with the flag over their laps. I learned so much that weekend and had a great time. Constitution Hall on the University campus is scheduled to be remodeled in the next few years, and the flag will be placed there when it is completed. In the meantime it will be stored at the University Museum.



Iditarod 2006: The 34th Running of the... dogs, mushers, sleds, and the covers!



The thirty-forth running of the Iditarod Sled Dog Race from Anchorage to Nome got started on a very foggy Saturday morning (March 4th) on Fourth Avenue in downtown Anchorage. As the eighty-three teams waited for the 10:00 am starting time, the temperature rose to 26°F and the crowds started to gather up and down the avenue and along the outgoing trail.

The ceremonial start had to be shortened to just eleven miles, instead of the twenty miles it usually runs from Anchorage to Eagle River, because of bad trail conditions. That didn't seem to bother the mushers—the *Idita-riders*—or the dogs, as the excitement and noise grew as the first team came to the starting line.

The re-start of the race took place at 2:00 pm the next day. Due to lack of snow in the Wasilla area, the re-start had to be moved north to Willow for the third time in the past four years. The competition was great, as most of the top-twenty teams from last year's race were running once again. Five former champions were looking for another joyful trip to the burled arches in Nome.

The race was exciting, and the lead changed hands a number of times. Montana musher Doug Swingley, Kasiloff musher Paul Gebhardt, and Denali Park musher Jeff King were the top three most of the way. Swingley was first to McGrath and the halfway point of Cripple. Gebhardt was the first to Ruby, but he had not taken his mandatory 24-hour rest yet, and Swingley and King soon passed him. Jeff King was the first musher to the coast village of Unalakleet, with Swingley hot on his heals. While Swingley rested his team for eight hours, King left after just six hours, and that was the end of it. King never gave up the lead, and arrived in Nome for his fourth victory.





Figure 2. (70%)

It was the kind of finish any musher would wish for. The moon was full, the temperature was 7°F, and the winds were calm. He crossed under the burled arch at 1:11 am on March 15th for a total time of 9 days, 11 hours, 11 minutes and 39 seconds. His fourth victory ties him with Susan Butcher, Dour Swingley, and Martin Buser. Rick Swenson remains the only 5-time champion. King, age 50, also earned himself the distinction of being the oldest musher to win the race. Swingley finished second and Gebhardt third, followed by DeeDee Jonrowe and John Baker.

Three mushers usually fighting for the top spot in the race had disappointing runs. Martin Buser finished 23rd, Rick Swenson 26th, and Ramy Brooks 31st. Rachael Scdoris, the legally blind musher who was forced to scratch last year, finished 57th. Of the eighty-three teams that

started the race in Anchorage, seventy-one crossed under the arch in Nome. Eleven teams scratched and one team was withdrawn.




Figure 4. (90%)

As happens every year, mail was carried by the mushers in this year's race. The "official trail mail" carried by every musher in the race is shown in Figure 1. Because of the size of the cachet, the bullseye cancel was used instead of any of the three specials cancels available during Iditarod time. The cover was carried by the 2004 winner, Mitch Seavey. Figure 2 shows Martin Buser's seventh cover. It has special cancels from both Anchorage and Nome. Paul Gebhardt continues to carry a cover whenever he races and his 2006 one is shown in Figure 3. The thirty-fourth cover in the set I produce is shown in Figure 4. It was carried by Noah Burmeister. It was canceled in Anchorage and back stamped in Nome.

Gold Nugget

George A. Brackett, former mayor of Minneapolis, Minnesota and engineer, was approached by a coalition of Skagway boosters to help build a wagon road from the city over the White Pass summit. Brackett had some experience in such matters, he had helped to build a portion of the Northern Pacific Railroad.

Work on what would be known as "Brackett's Wagon Road" began on November 8, 1897. Although the group that convinced Brackett had promised to raise the funds needed to build the road, they did not do so, and Bracket paid the startup costs himself. By the end of the year, eight miles of road had been opened up, but by then, Brackett was broke. He tried to charge a toll (\$1.00 per person; \$1.00 per pack animal; 25 cents per dog or sheep), but the mass of stampeders merely overran the toll gates.
