

Secondly, since the terms of all the current board members expire on December 31, 2007, I am reappointing all the Directors and Officers until they or their replacement can be elected. This is a serious matter that deserves the consideration of each member. As has happened in the past, I will be contacting all the current board members by e-mail to see if a slate of candidates can be put together and an election held early in 2008. Unfortunately, there were no responses to my request in the 1st Quarter, 2007 The Alaskan Philatelist issue asking for members who would be willing to serve on an ACC Nominating Committee.

The rules that govern our elections, the ACC Bylaws, are found on our website at *www.alaskaphilatelic.org*. You can also find them on page 23 of the 1st Quarter, 2006 TAP issue.

Personally, I think it would be helpful to the Alaska Collectors' Club to make some significant changes in how we conduct our business. One change I believe needs to be made in our bylaws is to stagger the terms of our board members. With two exceptions, at the present time all board members serve the same two-year term. The Secretary-Treasurer serves a four-year term, and the immediate Past President serves through the term of his/her successor. Nearly all other similar organizations I am familiar with have directors and officers who serve staggered terms.

In her message in the last TAP issue, Vice President Angela Watson suggested the ACC implement a policy that requires each board member to submit at least one TAP article per year in order to remain on the board. In other words, there would be at least one requirement for being a board member. Most certainly, this would require another change in our bylaws!

I will be appointing an ad hoc ACC Bylaws Revision Committee to study these and other suggestions. Are YOU willing to be a candidate for office and/or serve on a Bylaws Revision Committee?

Finally, I want to thank Eric Knapp and David Schwantes for producing the ACC's 19th Sustaining Member Cover. It's a great addition to any Alaska collection!



We have asked all the members to write about Alaska history as it pertains to philately for this publication many times. We thought maybe the reason we don't get much response is because the perfect topic was eluding you. So, we have compiled list brief list of Alaska history in several parts (other parts will appear in subsequent issues) for you to look over and if something intrigues you, please do a bit a research and write a short piece for inclusion in the next TAP. We really need your assistance.

February 27, 1954 William Snedden, owner of the Fairbanks Daily News-Miner, reverses the paper's editorial policy and begins advocating for statehood.

July 21, 1954 Douglas McKay, Eisenhower's Secretary of the Interior, lambastes "Operation Statehood" members at a speech in Anchorage. McKay stated that he was "sick and tired of being kicked around by Alaskans" and that citizens of the territory should start acting like "ladies and gentlemen."

August 14, 1954 Commonwealth for Alaska Inc. is founded in Anchorage. The group favored commonwealth status for Alaska as a step between territorial status and statehood.

September 13, 1955 In a special election, 55 delegates were chosen for the Constitutional Convention, which convened at the University of Alaska in November.

November 8, 1955 The Alaska Constitutional Convention begins at the University of Alaska in Fairbanks.

November 29, 1955 Former Territorial Governor Ernest Gruening's book "The State of Alaska" is published. The book detailed the history of Alaska and described the coming fight for statehood and prosperity.

February 5, 1956 The delegates to the Alaska Constitutional Convention adopt the constitution for the future State of Alaska.

February 6, 1956 The Alaska Constitutional Convention adjourns.

Gold Nuggets

Establishing New Post Offices in the Territory

During his first trip to Alaska, Postmaster John Clum established a number of post offices along the gold rush trails and in the Alaskan gold fields, including:

Sheep Camp • April 4, 1898 Joseph G. Brown, postmaster

Pyramid • May 11, 1898 Albert J. Paul, postmaster

Canyon City • May 18, 1898 Kenneth Murray, postmaster

Eagle City • June 25, 1898 Thomas McMahon, postmaster

Star City • June 25, 1898 John C. Hayes, postmaster

Ft. Yukon • July 4, 1898 Rev. John Hawksley, postmaster

Rampart • July 5, 1898 Milton P. Fleisehman, postmaster

Tanana • July 6, 1898 Rev. Jules L. Prevost, postmaster

Anwik • July 7, 1898 Rev. John W. Chapman, postmaster

Koyukuk • July 13, 1898 Frank Pickarts, postmaster

Valdez • August 12, 1898 Thomas A. Edwards, postmaster

Some of these post offices are among the most scarce and sought-after cancellations in Alaska postal history, including Canyon City (which rates as a Helbock 8!). This small tent camp on Chilkoot Trail was nine miles north of Dyea. It was said to have housed 3,000 temporary residents during the spring of 1898. Pyramid (also rated as a Helbock 8) was a village at Mile 64 on the Alaska Railroad, 12 miles NW of Whittier.

Also of note is Star City (also known as Starr), a mining camp on the left bank of the Yukon River, 11 miles NE of Eagle. The postmaster reported a population of 200+ in November 1898, but their mining boom was very short-lived and no known copies of this canel are known to exist



Alaska Cigarette Revenue Stamps

by Peter Martin

While Alaska Territory issued beer wine and liquor revenue stamps during the 1930s and 1940s, Alaska cigarettes did not require revenue stamps until 2004.

I am preparing a catalog of Alaska revenue stamps and since the state does not sell mint stamps to collectors, I am hoping that members of the Alaska Collectors Club may be able to help with these new issues.

The tax stamps were inaugurated January 1, 2004 and each year has seen tax rate increases and new stamp colors. All the issues are heat fusion stamps approximately 11x11mm in size. They have black inkjet control numbers.

The 2004 initial tax rate was five cents per cigarette and stamps were issued in 20 cigarette (blue on yellow) and 25 cigarette (black on green) varieties.

The rate was increased to eight cents per cigarette in January 2005 The 20 cigarette stamps became black on pink and the 25 cigarette stamps changed to black on orange. A third type of stamp, identified as NPM, was added that year. The purple stamp was for cigarettes manufactured by companies that did not sign the Master Settlement Agreement, a 1998 agreement between 46 states and several major tobacco companies. To date, 11 different stamps have been issued. They are listed below with the issued colors.

Gold	Nugget

Long before the stampeders began crossing over the Chilkoot Pass, the area of Dyea was used as a seasonal fishing camp. By the spring of 1897, that began to change. As word of the strike spread, stampeders began to trickle into the area. By that winter, the trickle had turned into a flood as thousands of stampeders slogged through the muddy streets, eating and sleeping in quickly-built restaurants and hotels. By 1898, Dyea had outgrown the town plan created only a year before.

Dyea's harbor was not as deep as Skagway's, which meant that most of the ships landed their cargoes at Skagway. Stampeders (including many who had purchased tickets to Dyea) were often left to make their own way

over to Dyea and the Chilkoot Pass trail. Although tens of thousands of people passed through Dyea on their way over the Chilkoot Pass trail, the town's population never exceeded 8,000.


The White Pass and Yukon Railroad meant the end of Dyea. The Chilkoot Pass trail may have been easier or better than the White Pass trail, but it could not compete with the railroad. The town faded away quickly. The post office closed down in 1902. By 1906, a man named E.A. Klatt was the town's only resident, who abandoned the town after tearing down and burning many of the buildings.

The area that was, for a few short years, a thriving community, has been reclaimed by nature. Little remains of the town today, except for the partial exterior of one building, bits and pieces of debris, and two rows of trees that were planted along main street and stand out amid the thick forest that covers most of the town.

First Days Issue in Large Format

This $8^{1/2}x$ 11 First Day of Issue page was created by club member Duane Heverling for the stamps issued for the 50th anniversary of the Alaska Highway. Mr. Heverling has been making first day covers for many years and has made this style of page for several stamp issues. This one has the Canadian highway anniversary stamp, the U.S. highway anniversary stamp, and several other U.S. and Canadian stamps that relate to the relationship between the U.S. and Canada. I asked Mr. Heverling about this page and he said they were fun to create, but this one was also difficult because he had to get the pages (along with his covers) to Dawson Creek for the Canadian Ceremony on May 15th and then back in time to take them to Fairbanks on May 30th. He says it was close. He also says all the stamps in each grouping are related in some way.

Letters Home from the Alaska Highway

Part II • transcribed by Eric Knapp

A couple of years ago I was at a stamp show in the lower 48 and a dealer offered me a collection of covers that included a correspondence from the Alaska Highway during World War II.

I purchased it and started looking at my purchase. I had 39 envelopes from a Marion Coleman addressed to his wife in Joliet, Illinois. 12 of the envelopes contained letters. The envelopes are numbered and in one of the letters Mr. Coleman indicated that he was trying to write every day. The letters were mailed in the Canadian civil mail system. All are postmarked at Whitehorse and bear Canadian stamps. None of the covers show any signs of postal censorship.

The return address was care of The Public Roads Administration, Whitehorse, Yukon, Canada. The Public Roads Administration (PRA) was in overall charge of the construction of the highway.

This is the second and final part of the correspondence of Marion Coleman, an employee of the Public Roads Administration (P.R.A.) involved in the construction of the Alaska Highway.

The letters provide a wonderful snapshot of life in a construction camp along the Alaska Highway.

Letter number 42 November 5, 1942

My Darling,

After mailing your letter last night I took a shower and was ready for bed when the mail box came around yelling

"the mail's in." I went over and had three letters from you. They were postmarked Oct. 26, 27 and 29. I went by before going to the office this morning and had two more from you postmarked Oct. 21 and 22, one from John, One form George and a carton of cigarettes from George. Noticed how they arrived. This is due to the weather. As long as the clouds are heavy we don't expect mail. As soon as it clears up the planes start coming in.

Your letters are you over and over. You are the sweetest thing. Honey, I can't explain the feeling I have when I receive your letters. The faith you express means everything to me. If there is any fellow as proud of his wife as I am of you I wouldn't know where to look for him. To know that you are sticking with me is a great consolation. Isn't it grand to be able to trust each other?

I read your letters over and over, getting a thrill each time. That little picture you sent of yourself is perfect. I showed it to all the fellows and now it is here beside me. I looked at it a hundred times today, falling deeper in love with you at every glance. I would rather loose my wallet than that. Thanks for the other pictures.

Eunice, make me one promise. Get plenty of sleep and don't work so hard. I am afraid you are overdoing things. If you don't get to my letter some nights I will understand. Your health comes first. You shouldn't loose weight.

I enjoy the bowling scores very much and am glad you are taking an interest in it. You really need the exercise and you can be a real good bowler with a little practice. I

> have sweet memories of all the times we went to bowling allies together. I believe I was jealous a few times at the club.

> You mentioned that your throat was infected. Do be careful. If your tonsils should come out you had better see to it at once. They can impair your health.

Thanks for sending a few of your sizes, but the jackets I mentioned



are well enough constructed, but I don't like the styles. Everything here is Indian style. I will try to find you a nice pair of bedroom slippers. I am keeping my eyes open for fur such as fox, but they are all so high and then I would have to pay a duty to get them into the U.S. Everyone says it is a lot cheaper to buy them in the states. I would like to get a nice bear skin rug.

I am sorry about your raise, but don't worry as you will probably get it later. If you never get it you are still worth a million dollars per week to me. Keep after Mr. Frieberg. It isn't fair, but I am sure he will do all he can for you.

So Garner took Jack's place. I thought Pat was after it. Chapman told me before I left that if Garner got it he was going to resign. He will probably cause a lot of discontent in the office.

Darling, about the work for girls here. As I stated in one of my other letters, there is some talk that Dowell Construction Company will hire girls here in the spring, but nothing definite. However, I am attaching their address with a little note. Write them a letter at once, but I suspect their letter will state that they are not hiring girls yet. If you should get a letter from them stating that there was a possibility of using you I don't know whether I would approve of it or not. I would give anything to have you here, but I know you would never be satisfied here as there is nothing in the way of entertainment. Write the letter and we will talk about that later. Don't say a word about it to anyone, not even our folks. They would probably think we were crazy.

My greatest worry now is Christmas. For the first time in my life there is not a thing I want, with the exception of you. I have everything I want here and there is nothing at all that I can use. I would like a watch, (yellow gold) but don't want it sent here as my watch keeps perfect time and it would only be ruined in shipment and use here. Here's what I suggest, you give me a watch for Christmas, but not until I come home. It would be foolish to buy it and put it back, so let me make

another suggestion. Just as soon as I say I am coming home you buy me a wrist watch and that would be my Christmas present even if it's in Feb. I hope you don't think this is a foolish idea of mine, but I think it is the most sensible thing as far as my present is concerned. Any suggestions you make will be appreciated.

Now, for your present. Be sure to state in your next letter just what you would like to have. Regardless of what it is I will see that you get it. Due to the mail service you must tell me at once. Darling, don't forget.

Regarding gifts for our folks, I will leave it up to your judgment. I will send you a list of the ones to send Christmas cards to. Honey, I hate to put all the responsibility on you as I know it's a big job, but I am sure you will understand my situation. My hands are tied and I can't do a thing about it.

The thought of Christmas makes me feel rather sick at heart. I know how happy you and I could be together, but I am sure it won't be possible. I want you to be happy and next Christmas we will make up for it.

Honey, it's getting late and I will answer your other questions tomorrow.

I will place that lovely picture of you close to my bed where it will be the first and last thing I see. I always go to sleep thinking of you and wake up the same. I often wonder what I would think about if I didn't have you. No thoughts could be as sweet.

Good night my love, Marion



Letter 43 November 6, 1942

My Dearest Eunice,

I gave the letter I wrote to you last night to a fellow this morning to mail for me and a moment ago he came back in with it. He forgot to mail it, so this one and last nights will be mailed together.

The worst thing happened tonight at dinner. The chief auditor for the P.R.A. came over to our table and said he wanted to talk to me. I had a feeling that I know what it was all about. He said I was about the only one that took an interest in my work and he was going to see that I stayed on the job this winter. He said after a few weeks he wanted me to work with him. I really appreciated the interest he showed in me, but I was sorta in hopes I would be furloughed for a little while. I can probably work into something good in a little while which might help me later on.

Honey, I have thought the above over and here is what I have decided. I will not say how long I am going to be here, but anytime I feel that I must see you I will get a leave.

Back Issues of TAP

1959 - 1973: Computer scanned & edited copies

The state of the state

If you feel at any time that you must see me don't hesitate to let me know. I don't want our separation to have any affect on out love whatever. I know I can't stay away from you very long. After a month or so more I can take a leave if pay my way home and the P.R.A. will pay it back. We will make some arrangement if I stay so I can be with you at least a few days after the first of the year. They might still send me out if the weather gets real bad.

I think I told you in my letters before the type of work I am now doing, but I will explain it again. It's in connection with production cost. We are getting an estimate of the cost per mile of the highway and at the same time trying to keep down the cost as much as possible. That is one reason I have traveled around so much. I go into a camp for a few days and see that everything is going according to the way it should. I determine the expense for a few miles, at the same time I get reports on equipment and employees. If a piece of equipment is idle I report it so, stating the exact reason. If a truck driver is doing other work other than driving a truck I also state that. I make two reports each day and then here in the office it is all put together showing the mile posts. That gives an idea of what each mile is costing and ways that cost can be reduced. The equipment must keep rolling unless there is a good reason for its idleness and the men must work in their classification.

You asked about pictures of me. Well, here is what happened, but I think they will get it straightened out. I had five of the best roll of film sent in to be developed and through some mistake they got my name down as Marion D. Clemens. When I went to the drug store after them they told me that they had no pictures for Coleman. I was sure they were wrong so they looked again and asked me my first name. They then looked at the books and said they had pictures at one time for Marion D. Clemens, but they had been taken out. The fellow said that he was sure he knew the party that got them. If they didn't bring them back he would go over and see. I am supposed to stop by tomorrow. I certainly hope they show up as some of the best pictures I have taken were on the rolls. There were about six snap shots of myself taken at different times. As soon as I get them I will send them on to you.

Don't worry about me not having money. I have enough to do for some time. When I run short I will ask

you to send me some or I will have it cut out of one of my checks. Be sure to let me know every time you get a check as they can be misplaced so easy in the mail. Always state the amount. If I am short I can raise a complaint here. I have no way of knowing.

John's letter took twelve days. It wasn't signed, but I knew who it was from. I am writing him tomorrow. I promised him one of those pictures you spoke of, so have some more made, not over six. Send me two of them as I will need them to get out of Alaska on my way home.

The "Par Avion" on the air mail envelopes is "By Air Mail" in French. The post office has a lot of French posters on the walls and almost everything one buys here has French printing on it even it it's made in Canada.

I will answer a few more of your questions tomorrow. Someday, I will get caught up.

Darling, take good care of yourself. Remember, "I love you with all my heart."

Letter 53 November 16, 1942

My Dear Eunice,

If I am half nuts when I get back you will know the reason why. The very same thing happens each day. After our regular routine of daily duties we then go back to camp. Most of the fellow lay around on their cots and

count the knots in the ceiling, but they are beginning to complain about that as the number remains the same. Everyone talks about going back to the states, but me. You know, I have stopped planning on anything. I want to come in to see you very bad, but I'll just wait until I get a chance. I am sure that is what you want me to do. I can always join the Army.

The temperature was 5 degrees below zero this morning. No mail has come in for several days due to the weather.

Did you buy bonds with the money from the ones we cashed in? The reason I ask is because there is a possibility that persons buying one fourth of their salary in bonds can deduct this amount form their income tax. That was the talk before I left the states, but I don't know what has happened since. What do you think of buying two \$100 bonds now. That is the best place a person can put their money.

I sent the package today that I mentioned in one of my letters. Please excuse the way it is wrapped as it is very slouchy, but I am not responsible. A girl down at the store fixed it up for me and all I did was address it. Oh yes, she asked all about you, how long I had been married, etc. I think everybody in Whitehorse knows you now.

With a wife as swell as you I can stick it out for a while yet. I am really glad that we married when we did as I am so proud of you. I have everyting I want to come back to. As long as I know you are well and happy I won't worry too much.

Letter 56 November 20, 1942

My Darling Eunice,

It is now 11:30. We just returned from the dedication. We missed the main part as we thought it was to be at 10:00 A.M. and it came off at 9:00 A.M. We arrived about 9:30 and all

we missed was the cutting of the ribbon. It didn't amount to much as mostly newspaper men attended. I was rather disappointed, but due to the weather conditions, we were unable to get any good pictures.

I got a letter from Mother today and one from George. Her letter was dated Nov. 9 and George's Nov. 17. Mother said she received a nice letter from you. I haven't heard for you for a long time and doubt if you have received any late letters from me, although I have sent one each day. The weather has delayed the mail here for about ten days. This will probably happen several times this winter so don't worry. If anything ever happens that you should know in a hurry you will receive a wire and I am sure you would do the same.

I thought of you a thousand times today. I would give anything to be with you tonight, but know everything is for the best. Remember honey, if the time comes that you feel you can't go on without me let me know and I will come back. I will never love another regardless of what happens.

Answer my letters regarding Christmas at once.

Dearest Wife,

It won't be long until I have been here two months. Honey, almost every minute of that time I have thought of you. There isn't one person here as deeply in love with their wife as I. Why shouldn't I be? I have the best.


It makes me sick the way most of the fellows act here. It is the most disgusting thing. I am referring to the way these fellows chase after the Indian girls. I think that is the lowest thing a person could do.

I received no mail from you today, but expect mail tomorrow. T was reported that there's a big lot coming in tonight. This will be the first from the states for about ten days.

Try to find out more about where Stack was headed. He didn't show up for the P.R.A., and as I don't know his real name I am unable to check up at Dowells' Construction Co.

The weather has turned out real nice. If it's nice tomorrow I intend to take some more pictures.

The skating rink that I told you about in one of my

other letters didn't turn out so hot. We had machinery working on it for several days, but when we started to flood it we ran out of water. We have given it up now. There are a lot of lakes close here and we can skate on the river before long.

There's no news that I can tell. I don't know anymore about a furlough.

I hope you are well and making it alright. Bear in mind that I am with you in everything you do. Don't hesitate to tell me everything.

Letter 58 November 22, 1942

My Darling,

There's no mail yet. The last letter I received from you was exactly ten days ago. Anyhow, I can look forward to a lot of mail some of these days. The mail was supposed to come in last night and if it did, it hasn't been sorted. You probably wonder why I use so many 3¢ stamps on my letters. The post office can't keep in airmail stamps, they are always out.

We just finished dinner. Every Sunday we have the same in the way of food. They serve turkey, pumpkin pie, etc. I am wondering what we will have Thanksgiving. Everyone's tired of this mess.

Honey, you haven't missed a day's work since I left, have you? I am afraid you are working too hard. I am afraid you are working too hard. Promise me that you won't overdo it. Are you going home for Christmas? I wish I could be there with you. I want you to have a real nice Christmas, but I am in a place where my hands are tied and I can't do much to make it enjoyable for you. That is one thing that worries me.

It really pleased my folks that we got married. Mother stated in her letter again the other day that you were everything they could ever expect in the way of a daughter in law. They will always be proud of you.

I am not broke, but I would like for you to send me \$20.00 anytime it's convenient for you to do so. Just put a twenty dollar bill in a letter and register it. I have enough money to do a long time, but don't want to get too low as one never knows what might come up. You don't have to hurry about this.

Being apart as we are has proven one thing. We were meant for each other and can be true regardless of the distance between us.

Gold Nugget

Banking on the Stampeders

Dyea vs. Skagway

For most stampeders, deciding to leave for the Klondike was easier than choosing a route. The media and public frenzy surrounding this gold discovery was unlike anything that had come before. The public was flooded with questionable reports, advice and maps, much of it from promoters, con-men and self-proclaimed experts scrounging for profits from the tens of thousands scrambling north.

Erastus Brainerd, a Seattle civic promoter, wanted stampeders to consider his city the best departure point for the gold fields. He mailed copies of the Seattle Post-Intelligencer --full of breathless stories of the gold discovery--to 70,000 postmasters for display in post offices. Brainerd's

strategy was extraordinarily successful. From 1897 to 1899, Seattle merchants alone took in millions of dollars from departing stampeders, considerably more money than miners brought out of the Klondike in the same period.

The competition for stampeder dollars continued in Dyea and Skagway, Alaska, the towns at the trail heads for the two most popular routes over the mountains, the Chilkoot Pass and the White Pass . Both towns could be reached by ship and were less than 10 miles apart.

Of the two trails, the Chilkoot Pass out of Dyea was the most popular until the first portion of the White Pass and Yukon Railroad was finished in July 1899, linking Skagway and Lake Bennett. By then, however, the majority of the stampeders were already in the gold fields.

Because there were no docking facilities at Dyea, ships unloaded cargo onto the beach, where people scrambled to get all their goods to high ground before high tide. Men were available for hire to help cart crates and boxes off the beach. The going rate was \$20/hour at low tide, but \$50/hour when the tide was rising.
